Old Business

- Community Partner Status update (POC Bob)
 - A few of the Community Partners memberships has expired (Grounds four Coffee in Clearfield, LSI, and Rovalis). It was decided to take Rovalis' donation and renew its membership since it was the Community Partner of the year for 2018.

- Use of Photos on Chapter Websites//Copyright Infringement complaints (AFA National)
 - AFA National raised the concern of using unauthorized photographs on Chapter websites. The Chapter members discussed AFA policy for using Rube Goldberg, Scowcroft, Snowball Express, and Invictus games photographs and gaining permission to post. Further research will be accomplished to prevent the Chapter from any copyright infringement.
 - O AFA headquarters frequently uses photos that are available on the Defense Visual Information Distribution Service (DIVIDS) website. Photos on this site are not protected by copyright. This is the source of most of the photos that are used by the AFA staff and encourage the Chapters to use this source as well.

- Jim mentioned that in the past the Chapter has been provided permission to use sponsorship logos on the website.
- Scowcroft March 21, 2019, Hot wash
 - Attendees liked the ½ earlier start (1730) because it ended earlier
 - Attendees liked the shorter citations and taking pictures at the end with the General Clark
 - Attendees liked 2 Emcee
 - Angie placed all Scowcroft material on Google Drive
 - Personal handwritten thank you cards were sent to Gen. Clark and Gen. Stoss
 - Emails sent out to senior leadership and industry partners
 - Update Industry Partner table tents
 - A few Tier sponsors did not pick up their bling
 - During registration it's important to identify who is actually attendee for the nominees and industry partners
 - Meet with Protocol earlier than a few days prior to the event (new protocol officer in 2020)
 - Muns award need to reevaluate for 2020
 - It was suggested by Protocol to designate Scowcroft an official event. There are pros/cons to this suggestion. Jim raised concern that the Jag office will take over direction but leaving the event as is will provide the Chapter flexibility.
 - There were a few award plaques that had typos-one will be fixed and sent to the nominee the others were minor typos and will not be fixed
 - o The plaques were smaller this year and required significant citation tailoring
 - o Prior to event pick up the flags at Protocol-UMA did not provide flags
 - Protocol came in with last minute table seating changes for the nominees and guests. It created last minute scurry but it all worked out.
 - AFA needs to recruit at this event more. Maybe place a business card at each place setting with information on our chapter and how to go to AFA.org to sign up
 - Need to tell the "Industry Remarks" speaker that they are there to "give thanks" to the Air Force for being able to be an industry partner 6 minutes is too long. 60-90 seconds is the goal.
 - Order of awards
 - Match the order of the awards in the program with the script
 - Move the ICBM Maintenance and Logistics Awards to the end. This is the "main event" of the awards and should be saved for last
